In 1961 MPVA was established as a member chapter of the Paralyzed Veterans of America. Since that time, tens of thousands of veterans have turned to MPVA for services, information, advocacy, education, recreation, fellowship and most of all - hope.

Advocacy

MPVA's Presentations to the Board of Governors at Wayne State University and the Board of Regents at the University of Michigan made them aware of the ways each campus currently fails to meet the needs of its students with disabilities. MPVA continues to follow the progress of significant projects at each state-funded school and act as needed to advance the rights of disabled students, faculty, staff, and guests. Changes at Detroit Metropolitan Airport prompted the formation of a coalition to address the Wayne County Airport Authority regarding lapses in ADA standards and practices. MPVA assisted the Detroit Riverwalk Conservancy by reviewing architectural drawings and making on-site visits to the \$140 Million dollar riverfront project to ensure compliance with federal accessibility guidelines. MPVA continues to represent consumer interests on the Northwest Airlines Customer Advisory Board on Disabilities.



Service Office

\$3.5 million was paid directly to Michigan households thanks to MPVA Service Officers who assisted local veterans with free services in filing or re-filing claims for VA benefits. MPVA reaches out from offices in Detroit, Ann Arbor, and Battle Creek.

Communications

MPVA added sponsorship of the weekly radio show "Disabilities Today" (1400 AM WDTK) to its diverse communications efforts. We upgraded our membership publication "Rollin' Times" to a four-color magazine. Our website (michiganpva.org) moved to a new server, helping us keep the site up to date year-round. Thousands of visitors logged on to ThePumpGuide.com for information on statewide gas stations eager to assist disabled drivers with full-service fill-up. Michigan's Secretary of State enthusiastically promotes this free

service by including information in customer mailings

Legislation

MPVA worked with the Michigan Secretary of State in selecting first-ever voting machines specifically for citizens with disabilities. Single-family homes built with state funding will incorporate basic accessibility functions following passage of the MPVA-supported Inclusive Home Design Act. Future funding for the Michigan Veterans Trust Fund was secured as MPVA supported Public Acts 248 and 249 of 2005, reassigning the Tuition

Grant Program to the Michigan Higher Education Authority and inviting citizens to fund these veteran benefits through a check-off donation made while filing state income tax forms. Liaison MPVA remains active in its work with VA hospital SCI/D Support Groups and with the University of Michigan Spinal Cord Model Care System in Ann Arbor. We connect with the leaders of Michigan's Veterans Homes in Grand Rapids and Marquette, and seek ways to enhance the quality of life for residents of those fine facilities.

Membership

The MPVA community includes 278 service-connected members and 289 non-service connected members. We also welcome associate and corporate members in support of our mission. Our April Open House during Michigan Paralyzed Veteran Awareness Week featured corporate member displays and visits from the then PVA National Vice-President Gene Crayton, Congressman, Thaddeus McCotter and David Landry, Mayor of Novi.

Sports and Recreation


MPVA partnered with adaptive sports programs statewide to offer events for all ages and interests, including rugby, basketball, golf, air rifle, soccer, billiards, track and field, hunting, fishing, and, for the first time, softball. In another historic first, MPVA sponsored the Disability Division of the 29th Detroit Free Press / Flagstar Bank Marathon. 13-year-old Adam Rose was among the many handcyclist and wheelchair racing participants who braved Michigan's cold October winds to complete the 26 mile course along side 16,000 able-bodied runners.

Fundraising

MPVA's 3rd annual "Salute to Veterans" event drew 300 attendees to the Ford Conference and Event Center in Dearborn on November 10, where chapter President Kevin Elya presented Brigadier General Carol Ann Fausone with MPVA's prestigious Birdsong Award for distinguished service to veterans in the State of Michigan. Keynote speaker Ron Gettelfinger, UAW President and USMC veteran, reminded us of the unending sacrifices we have made, and will continue to make, for freedom. In 2006 MPVA was presented with generous donations from groups like the patriotic motorcyclist group Rolling Thunder #5, of Brighton. The funds were raised in support of the Ann Arbor VA Wheelchair Teams' participation in the National Veterans Wheelchair Games held in Anchorage, Alaska.
